RE: BUS TRANSPORTATION FINAL COSTS FOR 2014-2015

1. <u>Background</u>

School bus transportation contracts for Lakehead District School Board were based on a formal procurement process and negotiated efforts with the coterminous board and our service providers. References to changes in the 2014-2015 contract amounts refer back to the previous year.

- 2. <u>Situation</u>
 - 2.1 With respect to the 2014-2015 contracts, Lakehead District School Board has secured fully tendered routing for busing services through Student Transportation Services of Thunder Bay (STSTB).
 - 2.2 Utilization of the MapNet computer program for automated route planning accurately measures the length of all routes adjusted annually for student address changes. This year there was an increase in the daily distance by 4 km/day bringing the daily distance total to 12,758 km.
 - 2.3 The 2014-2015 transportation funding formula contains a *Fuel Escalator/De-Escalation Clause* to help provide additional funding stability despite market volatility of fuel prices. The Ministry of Education has pegged fuel funding price at \$0.957 per liter, plus or minus three percent. If fuel prices are above or below this spread in any month within the fiscal year, a funding adjustment will apply.
 - 2.4 2014-2015 fully tendered and audited routing resulted in the following monthly contract amounts (not including HST):

3. <u>Conclusion</u>

The changes to this year's bus transportation contract rates allow Lakehead District School Board to continue to provide safe, high quality transportation services to students in Thunder Bay and the surrounding region.

RE: MENTAL HEALTH UPDATE

1. <u>Background</u>

- 1.1 *Open Minds, Healthy Minds* is the Government of Ontario's comprehensive strategy to address mental health and addictions for all Ontarians. The first three years of the strategy are focused on children and youth.
- 1.2 Lakehead District School Board established a Mental Health Steering Committee in November 2011. Current members of the committee are:

David Tranter, Mental Health Leader (Chair); Colleen Kappel, Superintendent of Education; Lori Carson, Special Education Officer; Debra Parks, Social Worker; Vicki Shannon, Elementary Principal; Leslie Hynnes, Education Officer; Jeff Upton, Education Officer; and Darryl Fawcett, Elementary Teacher.

- 1.3 Lakehead District School Board continued to receive funding from the Ministry of Education to maintain a Mental Health Leader for 2014-2015. Dr. David Tranter began his placement as the Mental Health Leader in September 2014.
- 1.4 As outlined in the Multi-Year Strategic Plan, Lakehead District School Board is committed to enhancing mental, physical and social well-being through a safe, inclusive and equitable environment.
- 1.5 The Ontario Government's Mental Health Strategy priorities for education are:
 - 1.5.1 Fast Access to High Quality Services
 - build capacity in the community-based sector;
 - reduce wait times;
 - meet community needs; and
 - link education, child and youth mental health, youth justice, health care and community.

- 1.5.2 Identify and Intervene Early
 - provide tools and support to those in contact with children and youth so they can identify mental health issues sooner; and
 - provide resources for effective responses to mental health issues; and build mental health literacy and local leadership.

1.5.3 Close Critical Service Gaps

Increase availability of culturally appropriate services and serve more children and youth:

- in Aboriginal, remote and underserved communities;
- with complex mental health needs; and
- at the key transition point from secondary to post-secondary education.

2. <u>Situation</u>

2.1 Mental Health Strategy

The Mental Health Steering Committee has met monthly to review the current Mental Health Strategy. The Strategy will be revised for 2015-2016 to make it more succinct, clarify priorities, and to better align with new Ministry of Education initiatives such as the inclusion of well-being in the Achieving Excellence (April, 2014) document. Mental health programs that currently run in our schools are being reviewed to ensure that they are being properly implemented, are evidenced-based, and represent best practices in their area.

2.2 Mental Health Awareness and Promotion

The Mental Health Leader is providing ongoing mental health presentations and training to staff, parents/guardians and student groups. Topics covered to date have included: Teaching Well-being in the Classroom, Resilience and the Growth Mindset, Overcoming Anxiety, Teaching the Teen Brain, Depression, Suicide Prevention, Self-Regulation and Executive Function, Parenting, and Developing Healthy Relationships.

2.3 School Social Workers/Attendance Counsellors

Each of the three School Social Worker/Attendance Counsellor positions now includes the Attendance Counsellor role. Two are dedicated to secondary schools and one to all elementary schools. The combination of the two roles is requiring an adjustment for the School Social Workers/Attendance Counsellors as they seek to find the best balance between their responsibilities. The Mental Health Leader meets regularly with each of the School Social Workers/Attendance Counsellors to provide support and supervision.

2.4 Central Attendance Team

Monthly meetings are held with the School Social Workers/Attendance Counsellors, Mental Health Leader and Superintendent of Education to review all students with attendance concerns. The team discusses strategies and develops plans to improve attendance for each student. These meetings have led to a number of actions including meetings with staff from Fort William First Nation, Ontario Works, and Dilico.

2.5 Mental Health Nurses

The North West Community Care Access Centre (NWCCAC) recently received funding to add a second half-time Mental Health and Addictions Nurse (MHAN) position for the Board bringing the complement to 1.5 MHANs. The other MHAN works closely with the School Social Workers/Attendance Counsellors to coordinate services to students. The Mental Health Leader meets monthly with the MHANs and the NWCCAC Program Manager to discuss the activities of the MHANs.

2.6 School Counselling Intervention Program (SCIP)

The program, administered by Children's Centre Thunder Bay, has expanded to include elementary schools. The SCIP counsellors and the School Social Workers/Attendance Counsellors work together to ensure good coordination of counselling services and ongoing communication regarding students at risk. Recently, the potential for expansion of the SCIP program has been discussed.

2.7 School Climate Survey

The "Tell Them From Me Survey" will be replaced by an internally developed survey by the Mental Health Leader in consultation with Principals and staff throughout the Board and with the assistance of graduate students from Lakehead University. The new survey will be called the SHARE survey (Safety, Health, Achievement, Relationships & Environment). The advantage of the SHARE survey is that it will be of minimal cost and can be adapted and improved over time to ensure that it is of value to schools in developing and evaluating school improvement plans. The survey will be administered in spring 2015.

2.8 Staff Wellness

Given that the promotion of mental health and well-being among students starts with the mental health and well-being of staff, enhanced efforts to support staff have been initiated by the Mental Health Leader. This has ranged from giving a talk to administrators entitled "The Depleted Administrator and How Not To Be One!" to directly supporting staff following critical incidents in schools.

2.9 System-Wide Mental Health Programs

Since all mental health programs are currently being reviewed, no new systemwide programs have started for the 2014-2015 school year. However a range of programs have continued from the previous school years and some have been enhanced to ensure comprehensive coverage throughout all schools. For example, the Circle of Wellness program that combines art and mental health activities for Grade 5 students is running in all classes including at Armstrong Public School. See Appendix A for a list of current programs in schools.

2.10 Relax and Restore Rooms

Last year the Board partnered with the Children's Centre Foundation to establish a Relax and Restore Room for students at Superior CVI. Students' fund-raising efforts are matched by the Foundation and the Bell Let's Talk campaign so that each school is eligible for up to \$5,000 in funding. This year each of the other three secondary schools are fundraising to establish Relax and Restore rooms of their own.

2.11 Violence Threat and Risk Assessment in Schools

Many staff throughout the Board have received Level I and Level II training in Violence, Threat and Risk Assessment (VTRA) from the Canadian Centre for Threat Assessment and Trauma Response. A community-wide, inter-agency VTRA protocol is currently being developed to improve communication and speed upon response time should a threat to schools be identified.

2.12 Crown Ward Education Championship Team (CWECT)

The Mental Health Leader is working as part of the community CWECT Team to improve educational outcomes for youth in care. The Board has recently applied for (and will receive) special funding from the Ministry of Children and Youth Services to develop an inter-agency protocol to identify, track and support youth in care at school.

2.13 System Alignment and Collaboration

In keeping with the revision of the Mental Health Strategy and review of mental health programs, a greater effort has been made to better align the goals of mental health and well-being with other portfolios such as Special Education, Equity and Inclusive Education, Safe Schools, Student Success, Healthy Schools and Aboriginal Education. The Mental Health Leader is working closely with leads in each of these areas.

2.14 Community Linkages

The Mental Health Leader sits on a variety of community committees to represent the Board and to better coordinate services that mental health agencies provide to our schools. Such committees include: Youth Suicide Prevention Task Force, Healthy Kids Thunder Bay Task Force, Drug Education Table and others.

3. Key Actions

- 3.1 The Mental Health Strategy is being reviewed and revised for 2015-2016.
- 3.2 The roles of the School Social Workers/Attendance Counsellors are being carefully monitored to ensure success.
- 3.3 System-wide mental health program are being reviewed to ensure that they are being properly implemented, are evidenced-based, and represent best practices in their area.

3.4 Mental health promotion and awareness training is being delivered on a weekly basis throughout the schools to staff, parents/guardians and student groups.

4. Next Steps

- 4.1 A revised Mental Health Strategy will be developed for the 2015-2016 school year.
- 4.2 The Mental Health Leader is developing a well-being policy discussion paper that examines how the Board might fully address well-being in schools.
- 4.3 The SHARE School Climate Survey will be administered in the spring of this year.
- 4.4 Ongoing training in a variety of mental health and well-being topics will continue to be provided to staff, parents/guardians and student groups.
- 4.5 An updated environmental scan of mental health and well-being activities in all schools will be completed by the end of the school year.
- 4.6 Following the review of system-wide mental health programs, some revision to program offerings made be undertaken to ensure that the best possible programs are implemented.
- 4.7 Direct support to Principals and Vice Principals will be given by the Mental Health Leader toward their efforts to improve the mental health and well-being of their students and staff.
- 4.8 A draft of the Violence Threat Risk Assessment Protocol will be completed by the end of the school year for review and consultation. It is anticipated that the protocol will be in place by December 2015.
- 4.9 A draft of the Crown Ward Education Protocol will be completed by August 2015 for official adoption and implementation in the fall of 2015.
- 4.10 The Mental Health Leader will continue to foster existing community partnerships and look for opportunities to develop new and meaningful partnerships.
- 5. <u>Conclusion</u>

Lakehead District School Board's Mental Health Strategy goals will guide actions in promoting and supporting the well-being of all students and staff.
