RE: REPORT ON THE ACTIVITIES OF THE 2016-2017 SUPERVISED ALTERNATIVE LEARNING (SAL) COMMITTEE

1. <u>Background</u>

- 1.1 In accordance with the Education Act of Ontario Regulation 374/10, the Board shall establish a Supervised Alternative Learning (SAL) Committee.
- 1.2 The role of the SAL Committee is to accept and consider applications from parents/guardians of compulsory secondary school age children, who are at least fourteen (14) years of age, and who wish to be excused from either full time or part time attendance at school. Where such applications are approved, the SAL Committee, in consultation with a representative(s) from the student's home school, and the student's parent/guardian, determines an alternative learning program directed towards the student's needs and interests.
- 1.3 During the 2016-2017 school year, members of the committee included:
 - Trustee Jack Playford;
 - Trustee Alternate Marg Arnone;
 - Colleen Kappel, Superintendent of Education;
 - Jeff Upton, Education Officer; and
 - Kendra Perry, Wendy Kohler and Cheryl Dillon representing YES Employment Services as external and alternate members.

2. <u>Situation</u>

- 2.1 On June 17, 2016, the SAL Committee met to consider SAL placements for 2016-2017 school start up. At that meeting, applications for students presently enrolled in SAL or the community based program incorporating both academics and work place readiness in partnership with SAL Youth Employment Services (SAL YES), were considered and appropriate recommendations for students' success occurred.
- 2.2 Twelve SAL meetings were held during the 2016-2017 school year. Forty-five applications were considered and forty-four were approved. Of these, nineteen went on to participate in SAL YES.

2.3 Eleven applications were received for 15 year old students, including seven females and four males. Thirty-four applications were received for 16 and 17 year old students (17 females and 17 males).
