RE: <u>STUDENT TRUSTEE</u>— FINAL REPORT

1. <u>Introduction</u>

I am incredibly grateful to have had the opportunity to serve as the 2017-2018 Lakehead District School Board student trustee. This year has been full of learning experiences and one that has taught me not just about education and leadership, but so much about myself. I have grown so much in the past few months as I carried out my roles in this position and am honoured to present my report to the Board for a final time this evening.

2. Year in Review

- 2.1 In September, I presented my first report to the Board, outlining my plans for the year and goals I hoped to achieve. These involved making my position more recognizable, as well as bridging the communication gap between students and the Board.
- 2.2 During the month of October, I was able to visit and meet with the student council executive members of all of the secondary schools, as well as their respective principals. The goal of these meetings was to introduce myself to some of the student population and make them familiar with my role. I found these meetings to be very effective in making personal connections and making students comfortable enough to address me with their concerns.
- 2.3 In November, I held the first Elementary and Secondary School Student Senate meetings of the school year. These meetings welcomed students who have been involved in past years, as well as new students looking to become more involved in their schools and community.
 - 2.3.1 The Elementary School Student Senate meeting took place at Sir Winston Churchill Collegiate and Vocational Institute. Nineteen elementary students attended from various elementary schools across the city. I am incredibly thankful to Leslie Hynnes, Education Officer and Ashley Nurmela, FNMI Aboriginal Liaison, for helping me facilitate this event, as well as the secondary school students who served as mentors. The senate met six times throughout this year.

- 2.3.2 The Secondary School Student Senate met for the first time at Mario's Bowl. Twenty secondary school students from across the city attended this event. This meeting served as an icebreaker to help students from the different schools get acquainted with one another and learn about what different schools are up to, all in a fun environment.
- 2.4 In December, I had the privilege of attending the International Baccalaureate Graduation Ceremony held at the Italian Cultural Centre. As a student in this program, I was pleased to see students be rewarded for their hard work and am thankful that the Board continues to support this program. I also began meeting with the Youth Embracing Diversity in Education (YEDE) planning committee to work on this amazing project.
- 2.5 During the month of February, I had the honour of attending the Board Council Conference hosted by the Ontario Student Trustee Association (OSTA-AECO) in Ottawa. I cannot describe how much I learned from this conference and the likeminded people who are as passionate about student voice as myself. I took away many ideas from this conference and it inspired many projects I took on in the remainder of my term as student trustee.

This month, the Elementary Student Senate was also fortunate to take part in the Harmony Movement Social Changemakers workshop. The two-day training was incredibly insightful, and the students went back to their schools ready to share all of their new knowledge.

- 2.6 In April, I organized the WE Walk for Water initiative through the Secondary Student Senate across the four secondary schools of the Board. The funds raised were donated to the ME to WE Foundation.
- 2.7 In May, I attended the Youth Embracing Diversity in Education (YEDE)
 Conference hosted by the Equity and Inclusive Education Working Group. I was honoured to interact with the student attendees and share highlights of my year in this role. I was also honoured to be the master of ceremonies at the Grade 8 Award of Excellence banquet. In addition, I had the opportunity to speak at the Thunder Bay Art Gallery's Fresh Perspectives: Secondary School's Art Exhibition on behalf of the students of our Board.

3. Regrets

- 3.1 I am disappointed in the turnout at the Secondary Senate meetings. Though the first meeting was a success, attendance dropped significantly at the following meetings. In addition, the Secondary Senate was only able to meet three times throughout the year. I plan to update the student trustee manual to help future student trustees develop a stronger Student Senate.
- 3.2 I found it difficult to attend additional committee meetings such as the Special Education Advisory Committee (SEAC), Parent Involvement Committee and the Equity and Inclusive Education Working Group. I believe that these meetings give the student trustee additional insight and knowledge about the education system and matters in our Board.

4. Recommendations for the Future

- 4.1 I would recommend future student trustees to start getting involved as early as they can in September. This would involve doing more planning at the beginning of their term in August and visiting schools and hosting meetings as soon as they can in the first month of school. This will help maximize the length of their term and make the most of it.
- 4.2 I would like to see more communication between the students of the Board and the student trustee on social media. A closed group on Facebook would be beneficial in reaching out to students, sending reminders and having on going empowering conversations. Simultaneously, a public page with updates of events and opportunities to get involved, as well as what is going on in the Board, would be helpful to keep students informed and involved, which is crucial for student voice to be represented.
- 4.3 I would recommend future student trustees to get involved with OSTA-AECO as soon as possible. This is an incredible group to be a part of, and had such a profound impact on my term, as it gave me the confidence to fully immerse myself in my role as student trustee. It also helped me meet some incredible student leaders from across the province, most of whom I am still in touch with.
- 4.4 It would be beneficial for the student trustee to have a two-year term if they are eligible. I have found the year goes by very quickly, and I still have many things I wish I could have done during my term. Having a two-year term will help the student trustee to accomplish more goals.

5. <u>Conclusion</u>

It is difficult to put into words how thankful I am to have had such an amazing opportunity. I have had the privilege of meeting and working alongside some amazing people over the course of my term. This has been an incredible learning experience for me, and I will take everything I have learned with me into the future. Thank you to everyone who helped me grow, not just in my role as student trustee, but also a person. I could not have had such an incredible experience without you.

1. <u>Background</u>

- 1.1 On January 27, 2000, the Minister of Education announced the government's plans for improving the quality of Special Education programs and services in Ontario and for ensuring greater accountability in the area of Special Education.
- 1.2 This year, boards have been requested to update the 2017-2018 Special Education Plan based on a checklist provided by the Ministry of Education. In addition, boards must submit the checklist and the Special Education Plan for the 2018-2019 school year. As per Regulation 464/97, school boards must continue to consult with their Special Education Advisory Committee.

2. Situation

- 2.1 The Special Education Plan is posted on the Lakehead Public Schools' website.
- 2.2 Special Education Advisory Committee (SEAC) members were consulted at their June 20, 2018 meeting on the updates using the checklist provided (see Appendix A). These amendments will be submitted to the Ministry of Education by July 31, 2018.
- 2.3 Amendments to the Plan include:
 - Section 2 General Model for Special Education: staff titles and new Ministry resources updated;
 - Section 4 Early Identification Process and Intervention Strategies: updates made to reflect full day, 2-year Kindergarten program and new Ministry resources/documents;

 - Section 6 Education and Other Assessments: updates to Board forms;
 - Section 7 Processes updated to reflect new community programs and program titles;
 - Section 9 Special Education Placements Provided by the Board: program locations updated:
 - Section 10 Individual Education Plan (IEP): Ministry resource document updated throughout;
 - Section 12 Special Education Staff: updated staffing numbers;
 - Section 13 Staff Development: Professional Development Overview;

- Section 14 Equipment: Updated forms and link to Special Equipment Amount (SEA) Guidelines;
- Section 17 SEAC: updated membership list and contact information;
- Section 18 Coordination of Services with Other Ministries and Agencies (Transitions): updates reflect changes in community programs (remove Intensive Behaviour Intervention (IBI) process, add Coordinated Service Planning (CSP) and Ontario Autism Program (OAP) information); and
- Section 20 Application and Referral Information: out of date referral forms removed, link provided to new forms.

3. <u>Conclusion</u>

Lakehead District School Board will continue to deliver high quality programs and services to students with special needs.

RE: STUDENT SUCCESS - TECHNOLOGY EDUCATION

1. Background

- 1.1 As outlined in the Strategic Plan, Lakehead District School Board offers a variety of high quality programs that reflect a continued commitment to student success to enhance life choices for all students.
- 1.2 The key elements for student success are guided by the four pillars of the Provincial Student Success Strategy. These include supporting:
 - Literacy;
 - Numeracy;
 - Community, Culture and Caring; and
 - Pathways.
- 1.3 Pathway programs provide students with experiential learning opportunities that support student engagement and achievement. These opportunities provide students with the ability to change and revise their goals and explore future career destinations.
- 1.4 Building and sustaining successful intermediate and senior division pathway programs is a shared school and Board responsibility.

2. Situation

- 2.1 To promote success in school and life, it is essential to provide opportunities and support for all students to plan their individual pathways through school and for each student to make a successful transition to a post-secondary destination, whether that is to community living, the workplace, apprenticeship training, college or university.
- 2.2 Partnerships and outreach opportunities increase opportunities for experiential learning so that students are able to participate in rich experiences and reflect on those experiences to derive meaning and then apply their learning to various aspects of their lives. Cooperative Education, Ontario Youth Apprenticeship Programs (OYAP), Specialist High Skills Majors (SHSMs) and Learning Academies provide students the opportunity to acquire knowledge and skills needed to make informed education and career/life choices.

- 2.3 Ontario Youth Apprenticeship Program (OYAP) allows a co-op student to begin learning a skilled trade while completing the requirements for a secondary school diploma. Ninety-three Lakehead District School Board students are signed OYAP participants while completing their co-op placements.
- 2.4 SHSM programs provide students with an opportunity to earn a Seal of Distinction on their Ontario Secondary School Diploma (OSSD) indicating the completion of a concentrated, sector-specific course of study. During the 2017-2018 school year, 150 students were enrolled in and were working towards a SHSM Seal of Distinction on their diploma. The 2017-2018 SHSM program choices include:
 - Arts and Culture;
 - Business;
 - Health and Wellness;
 - Manufacturing (two);
 - Transportation;
 - Justice, Community Safety and Emergency Services;
 - Construction:
 - Sports and Recreation; and
 - Aviation and Aerospace.
- 2.5 Dual credit opportunities under the School College Work Initiative (SCWI) continue to provide students with the opportunity to earn a secondary school and college credit concurrently, while attending their respective secondary school and Confederation College. Team-taught dual credit courses include Manufacturing, Transportation, Aviation and Justice. During the 2017-2018 school year, eighty-one students participated in SCWI team taught dual credits.
 - 2.5.1 College Now is a unique college delivered dual credit program offered at Confederation College to secondary school students from both the Lakehead District School Board and the Thunder Bay Catholic District School Board. This dual credit program supports secondary school students in completing their secondary school credits while considering their post-secondary education and transition to college.
 - 2.5.2 The Summer Centre for Learning and Student Success (C.L.A.S.S.) will continue to be offered as a program for students who need to complete curriculum expectations of a course they were unsuccessful with during the school year (credit recovery). In addition, senior students also benefit from a choice of four college delivered dual credit courses to support graduation and provide them with the skills to make more informed decisions about college pathways. Grade 10 students, with significant gaps in credit accumulation, will have an opportunity to enroll in an experiential learning summer program, Navigating the Workplace.
- 2.6. The Focus on Youth (FOY) program will be offered in partnership with Roots to Harvest and the Lakehead Adult Education Centre as a program for students who need support with employability skills. Twelve students will participate in a paid cooperative education program through the FOY program.

- 2.7 Success Certified is an annual program where students achieve employability certifications to assist them in their career and education pursuits by facilitating industry recognized certifications. Certifications and training include: Standard First Aid with CPR, Chainsaw Safety, Salon Assistant, Hoisting and Rigging, Snowmobile, ATV, Vessel Education, Working at Heights, Elevated Platforms, Safe Food Handling, Smart Serve and Service Excellence. Success Certified took place in the spring of 2017-2018 with 95 Lakehead District School Board students participating.
- 2.8 During the 2017-2018 year, all four secondary schools implemented a new program, *Equitable Access to Post-Secondary*, to support students uncertain about future education or career goals. Forty senior students had wrap around support and numerous opportunities to explore pathways and programs connected to their areas of interest to support their transition from Grade 12 or 12+ to post-secondary education or apprenticeship training.
- 2.9 Experiential learning opportunities provide students with a deeper understanding of future destinations, their personal strengths and potential programs and pathways for education and career training. Lakehead District School Board has six schools currently offering Learning Academies with four schools planning for implementation in the fall.
- 2.10 Lakehead District School Board has hired an Experiential Learning Resource teacher to support teachers in both panels as they extend student learning to the community beyond the classroom walls. Professional learning opportunities have been provided to educators to support their understanding of the *Creating Pathways to Success* policy.
- 2.11 This semester, 164 secondary students from across Lakehead District School Board participated in seven e-Learning classes. In an effort to expand student's choices in course selections, Lakehead District School Board is participating in the Northern e-Learning Consortium (NELC), sharing seats in our e-Learning courses in exchange for access to seats in other boards across the region.
- 2.12 In addition to online courses, many Lakehead District School Board teachers use blended learning to engage their students and enable communication beyond the school day. These strategies have shown considerable success in alternative education environments.
- 2.13 In addition to a variety of e-Learning options for our students, 28 summer e-Learning courses in Grades 10 to12 were made available through our "Northern E-School" program through the Lakehead Adult Education Centre. These courses allow students in our Board, as well as other northern boards, to recover credits and reach ahead through the summer.

2.14 The Homework Help Initiative (HHI) continues to support student achievement in Grades 7 to 10 mathematics. This program assists students through a free, secure, online chat room hosted by the Independent Learning Centre (ILC) where students in Grades 7 to 10 mathematics obtain after-school mathematics help. The online chat room provides students with mathematics support at home. This initiative provides families with a tool where students can ask mathematic questions in a secure, non-intimidating environment. Two Board Homework Help Tutor Ambassadors are available to staff and their students to promote the program and help with learning to use the resource.

3. Next Steps

- 3.1 The Board will be expanding the SHSM Program to include Hospitality and Tourism at Westgate Collegiate and Vocational Institute.
- 3.2 Community partnerships that support student pathways will continue to be developed and sustained. Opportunities for students to earn dual credits and to participate in 'reach ahead' experiences through the School College Work Initiative; Focus on Youth program; Navigating the Workplace program and Learning Strategies will continue to be available to Lakehead District School Board students.
- 3.3 Relevant data and other evidence will continue to be used to monitor the success of SHSM, OYAP, Dual Credit programs and Experiential Learning programs to inform next steps.
- 3.4 Projects that seek out student voices to inform school and system improvement will continue to be encouraged and supported.
- 3.5 Additional Land-based Learning projects will be implemented in 2018-2019 to support the Truth and Reconciliation Calls to Action providing community connected learning and a deeper understanding of the rich history and culture of Indigenous people of Canada.
- 3.6 The program department will continue to provide training to enhance student achievement through the use of technology to expand how, when and where learning takes place, authentically engage our students and provide students with the skills to excel in a digital age. Increased access to technology, combined with focused training, will support staff and students as they leverage technology to support school improvement plans.

4. Conclusion

Lakehead District School Board continues to provide high quality programs and opportunities for all students to ensure student success and support graduation. Pathways will continue to be supported and developed at both the school and system level to contribute to student success and to help reach every student.

Changes made to the plans include changing the facilitator office to accommodate for space for therapy specialists and a calming room. Additional outlets will also be added to accommodate for additional equipment within the area.

Additional plans for the new school include sound field systems in all classrooms and in the gymnasium. This system amplifies the voice of the teacher at a consistent level which assists students with hearing conditions. It has also been suggested that this system helps children to focus more on what is being taught as there is no disruption in the teachers voice no matter which direction she/he is facing when teaching.

A health office may also be added that could also be used for therapists. Additional flexible space is located on the second floor, which could be used for exercise bikes, etc.

1. <u>Background</u>

- 1.1 Bluewater District School Board (BDSB) sent correspondence to the chair of SEAC on April 6, 2018. The correspondence included a letter that Bluewater DSB sent to The Honourable Indira Naidoo-Harris, Minister of Education on April 4, 2018 requesting that a Provincial Think Tank be established to consider and plan for future technologies, artificial intelligence, and transformational innovations. Additionally, the letter requested that key stakeholders from the current education system, leading researchers and innovators be incorporated into the Provincial Think Tank.
- 1.2 The correspondence from Bluewater District School Board (Appendix A) was included in the correspondence folder at the April 18, 2018 Special Education Advisory Committee (SEAC) meeting and was discussed at the meeting.

2. Situation

2.1 One of the top priorities listed in the 2018-2019 SEAC Budget Deputation is technology, which includes exploring new advances in technology and ensuring that the best technology available used by students with special needs integrates with and connects to technology in the regular classroom to benefit all students.

SEAC recommended sending a letter to the minister of education supporting the establishment of a Provincial Think Tank as this aligns with one of the SEAC budget deputation priorities.

A draft letter to the minister of education was presented to SEAC at the May 16, 2018 meeting.

By consensus, SEAC agreed to send the draft letter to the Lakehead District School Board trustees and request approval to submit the letter to the minister of education.

2.2 Attached as Appendix B is the letter from the SEAC chair to the minister of education.

The Special Education Advisory Committee respectfully requests that the Board approve the request to send correspondence of support addressing the item presented.
