School: Westmount Public School

Title of Initiative: Exploring Truth-telling and Following our Hearts on the Path to Reconciliation: Our Journey from Project of Heart to Legacy School

Components of Initiative	School's Details
Description of the nature of the initiative to improve student achievement	All students need to see themselves within the curriculum and within the school. As a staff, we wanted to bring awareness of Indigenous culture, history, and perspective into our day to day teaching and learning toward reconciliation, and to ensure Indigenous students and partners have a more active voice within our school and school community. Student engagement in academics and extracurricular opportunities will increase when students feel represented and attached to the school. We seek to ignite passion and energy in our students to learn and work together in the spirit of reconciliation.
2. Rationale for selecting the initiative	Staff identified Indigenous education and reconciliation as a critical focus for us when we planned for this year, and we embedded this focus into our school improvement plan for the 2019-2020 school year (and moving forward).
Intended outcomes of the initiative related to improved student achievement	As a staff, we feel strongly that our focus on embedding Indigenous ways of knowing, literature, and experiential education into all subject areas, will help students gain a better understanding of the impact of residential schools on our school and broader community. We also believe strongly that it is our children who will be the true change makers in our collective efforts toward reconciliation as a country.
4. Description of the data used	Our staff have collected numerous examples of student work showing a growing understanding of the history and impact of residential schools, and students have identified that they are committed to continuing this learning as part of our community journey toward reconciliation. Our students have also identified a number or reconciliACTIONs as a legacy school with the Downie-Wenjack fund.
	Staff members have an improved understanding of the historical elements of residential schools and have more confidence teaching this difficult subject by using new resources acquired through Project of

	Heart, our Indigo Love of Reading Legacy library and community partnerships.
	Students attending our First Nation, Métis and Inuit (FNMI) book and video club (a positive space club where students spend time celebrating their differences and strengths), share experiences with community members, and learn about the gifts brought to us by Indigenous people in our community) have increased from a handful to more than 20 regular members. Students are actively participating in discussions and working with community partners.
Brief description of the significant activities or strategies involved with the initiative	Project of Heart Seeks to examine the history and legacy of residential schools and to support schools to seek the truth about that history, leading to the acknowledgement of the extent of loss to former students, their families and communities.
	Downie-Wenjack Fund Legacy School Helps classrooms/schools lead the movement in awareness of the history of Canada's residential school system.
	Community Activism and Fundraising – Wake the Giant/Dennis Franklin Cromarty High School Students are raising awareness about the importance of being change makers in our community by fundraising and learning with and advocating for Indigenous people in our community.
	I Read Canadian/Legacy Library Westmount Public School proudly participated in "I Read Canadian" celebrating Canadian books and authors with a specific focus on the richness of Indigenous literature available.
6. One or two highlights of the above activities	Students' passion for making our community a better place through their learning about the legacy of residential schools and identifying Dennis Franklin Cromarty High School and Wake the Giant as partners in learning and a focus for advocacy and fundraising efforts.
	Ongoing energy and desire for students and staff to continue their learning together and work together in the journey toward reconciliation.
7. Description of any unexpected results or "moments of serendipity" related to the initiative	We often teach students about things that happened in the past as something that only happened in the past. During our reading, students were shocked to learn that there was a residential school down the street from Westmount. This incited a level of empathy that we didn't anticipate. Students were

Description of one or two interesting findings that would be useful or helpful to other schools	motivated to do more. Through the "Have a Heart Project", our students wrote letters to the Prime Minister and began to learn about Dennis Franklin Cromarty High School. We hope to continue to foster this relationship through fund-raising for Wake the Giant and collaborative learning with students and staff at Dennis Franklin Cromarty High School. Sometimes an activity or learning opportunity like "Project of Heart" can be the catalyst to begin a school's journey or to move a school forward.
	The significance of highlighting Indigenous education and reconciliation in a school improvement plan is tremendous.
Identification of one or two noteworthy hurdles or stumbling-blocks	Impacting the broader school community can be a challenge too. Many adults do not understand or sadly, even value the work we are doing. A large portion of our school community does not have a good understanding of Indigenous culture and history. As a school, we need to invest in supporting our families to learn with us.
	We will celebrate together and work at making small impacts on our community through the work we are doing.
10. Next steps in pursuing the initiative	Continuing to follow a path towards reconciliation as we support our growth as a school community by working with students, staff, parents and partners. Continued involvement with Project of Heart (potential future project), continuing our work and reconciliACTIONs as a Downie-Wenjack Fund Legacy School, and advocacy for moving forward together toward reconciliation. We look forward to building a long-term relationship with Dennis Franklin Cromarty High School and also strengthening our relationship with Indigenous secondary students within Lakehead District School Board.
11. Lessons learned about the school's efforts to improve student achievement	It is okay for staff and students to admit that they do not have answers or understanding about different parts of Indigenous culture and history. Collectively, we are learning and getting better at moving toward reconciliation.
	Change takes time. Small steps like our First Nations Métis and Inuit book and video club builds community and capacity for our Indigenous and non-Indigenous students to work together for change. Mutual respect can grow through exposure to the past and a focus on, and commitment to, a better future.

RE: MENTAL HEALTH STRATEGY

1. <u>Background</u>

- 1.1 Lakehead District School Board is committed to student achievement and well-being and aims to promote resiliency and well-being of students and staff and ensure a caring and inclusive learning and working environment.
- 1.2 In partnership with Children's Centre Thunder Bay, a new mental health lead joined the Board in July 2019.
- 1.3 A one-year action plan has been developed and is currently underway.
- 1.4 The Board is in a planning year and will be developing the next three-year mental health strategy that will align with School Mental Health Ontario initiatives being promoted provincially.

2. Situation

- 2.1 School Mental Health Ontario resources are being utilized to increase mental health literacy among administrators, educators and support staff. The mental health lead provides resources and materials to support educators in classroom management strategies that pertain to students experiencing challenges in mental wellness.
- 2.2 System mapping of resources, related to mental health services and promotion in schools, is underway to better understand and streamline services provided to students.
- 2.3 The Board has an ongoing community partnership with Children's Centre Thunder Bay; four full-time social workers are providing clinical services with students in all city elementary schools and one part-time child and youth worker is providing specialized groups at Claude E. Garton Public School.
- 2.4 The Board has three social workers, one in each secondary school, and two attendance counsellors, who are committed to elementary and secondary students.

2.5 The Board has also partnered to work with Children's Centre Thunder Bay to access EMHWare, a cloud-based client management software to replace paper client files. This also ensures increased confidentiality, standardized documentation and accurate data collection and assists with client reporting for Ministry funding accountability. Social workers located in secondary schools are being trained to use the EMHWare database to record client information.

3. Additional Information

- 3.1 Through School Mental Health Ontario, social workers are able to access training on structured psychotherapy approaches that have evidence-based effectiveness in schools. Additionally, School Mental Health Ontario is in the process of offering online literacy training for educators and guidance counsellors.
- 3.2 A number of less formal partnerships exist that provide services to students in schools including:
 - Sullivan's and Associates delivering services to students who qualify for services under non-insured health benefits; and
 - Dilico Anishinabek Family Care who are working to streamline referrals with Children's Centre Thunder Bay social workers in the elementary schools and are specifically running Dialectical Behaviour Skills Group with appropriate students at Westgate Collegiate and Vocational Institute.
- 3.3 Schools continue to designate mental wellness champions to lead the dissemination of information gained from various training initiatives.
- 3.4 Children's Centre Thunder Bay continues to provide the school counselling intervention program.
- 3.5 School social workers work closely with the mental health and addictions nurse to support crisis situations and transitions to/from hospital. This has been a very successful partnership due to the team approach that has been developed.
- 3.6 Opportunities for wellness training are provided for all staff throughout the year. Mental Health literacy is a priority this year and will continue into the 2020-2021 school year.

4. <u>Conclusion</u>

School social workers, attendance counsellors, child and youth workers and the mental health lead are well respected and valued by students, parents/guardians, staff and community agencies and contribute to improved student outcomes through improved academic performance, increased attendance and improved classroom conduct.

RE: <u>INDIGENOUS CULTURAL SAFETY PILOT PROJECT</u>

1. Background

- 1.1 The Indigenous Cultural Safety (ICS) Pilot Program was funded by the Ministry of Education. Lakehead District School Board sought to explore the concept of Indigenous cultural safety with the aim to remove systemic barriers for First Nations, Métis and Inuit students in education.
- 1.2 Lakehead District School Board received funding for the ICS Pilot Program. The pilot program was reviewed by two ICS experts and approved by the Ministry of Education prior to implementation.
- 1.3 Lakehead District School Board is committed to "implementing programs and services to meet the needs of First Nations, Métis and Inuit learners" (Strategic Plan, 2015-2019)

2. Situation

- 2.1 In the winter of 2019, the Ministry of Education provided a comprehensive professional learning session on the foundational components of ICS, led by experts. At the ICS professional learning sessions, the Board team learned about the theory and framework behind Indigenous cultural safety as well as application and best practices of cultural safety in other sectors.
- 2.2 The pilot program was implemented with the support of the Aboriginal Education Advisory Committee, Board and school staff, and included Elders and Indigenous staff, both centrally located and those working in schools, who are more directly connected with the students.
- 2.3 The pilot was comprised of four key initiatives:
 - 2.3.1 Professional Learning:
 - to develop the knowledge and skills of leaders at Lakehead District School Board, to deepen understanding about Indigenous cultural safety, human rights and equity, and to foster respectful trusting relationships with Indigenous students.
 - 2.3.2 Bundled Credit Program at Westgate:
 - to enhance the learning experience of Indigenous students.
 - 2.3.3 Indigenous Student Leadership Pilot:
 - to explore what leadership means to the students and to understand how they can be supported at Lakehead District School Board.

2.3.4 A Closer Look at Alternative Education:

• examine representation and needs of students in alternative education.

3. Next Steps

Based on the feedback and input received to date, the following four priorities were identified:

- need for strategies:
 - practical knowledge about how to build safe and inclusive learning spaces to support student achievement and well-being; and
 - anti-racism to support well-being and success.
- Indigenous Youth Leadership phase two will focus on supporting students who want to be "doing better";
- information collected from professional learning sessions will continue to inform ongoing school and Board improvement plans; and
- bundled credit learnings will be shared once year-end results are collected.

The Aboriginal Education Advisory Committee will be consulted to provide further input regarding the four priorities identified.

4. Conclusion

Lakehead District School Board will continue to support the well-being and success of First Nation, Métis and Inuit students.
