TO THE CHAIR AND MEMBERS OF THE LAKEHEAD DISTRICT SCHOOL BOARD – Public Session

RE: ABORIGINAL EDUCATION

1. Background

- 1.1 Lakehead District School Board (LDSB) is committed to the success of every student and to the building of an equitable and inclusive community where all students feel they belong. The goal is to work with Indigenous peoples in the spirit of reconciliation to provide quality education.
- 1.2 We are in a historically significant time in Canada with respect to the relationship between Aboriginal peoples, Aboriginal education, and reconciliation for our nation. Our work in Aboriginal education continues to align with the truth telling and reconciliation process of the Truth and Reconciliation Commission of Canada. This commitment to establishing the principles of relationality, relevancy, respect, and responsibility will forge a brighter future for all students and staff of LDSB.

2. Situation

- 2.1 In line with the Ministry of Education's outline for the Board Action Plan on Indigenous Education, we continue to focus on four areas: supporting Indigenous student well-being, Indigenous student transitions and safety, Indigenous parent and community engagement, and continuing to build system and educator capacity.
- 2.2 Lakehead District School Board continues to act in response to the Truth and Reconciliation Commission of Canada Calls to Action; in particular, focusing on Calls 53, 62, 63, and 65 as they relate to public education:
 - provide education to public servants on the history of Aboriginal peoples, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal-Crown relations (Call 53);
 - in collaboration with survivors, Aboriginal peoples, and educators, LDSB is working to (Call 62):
 - make age-appropriate lessons on residential schools, Treaties, and Aboriginal peoples' historical and contemporary contributions to Canada;
 - educate teachers on how to integrate Indigenous knowledge and teaching methods into classrooms.

- maintain an annual commitment to Aboriginal education issues, including (Call 63):
 - developing and implementing Kindergarten to Grade 12 learning resources on Aboriginal people in Canadian history, and the history and legacy of residential schools;
 - sharing information and best practices on teaching curriculum related to residential schools and Aboriginal history;
 - building student capacity for intercultural understanding, empathy, and mutual respect; and
 - identifying teacher-training needs relating to the above.
- in collaboration with Aboriginal peoples, post-secondary institutions and educators, and the National Centre for Truth and Reconciliation and its partner institutions, establish a program to advance understanding of reconciliation (Call 65).

3. Education for Reconciliation

Currently, LDSB is responding to the *Truth and Reconciliation Commission of Canada:* Calls to Action in a number of ways:

- over 250 staff members have participated in Cultural Mindfulness Training to build Aboriginal cultural and historical understanding;
- five cycles of Cultural Sensitivity Training system-wide have been completed. Most recently, the training titled Truth, Reconciliation and Rights – Opening Doors to Education was delivered to all staff;
- a Cultural Safety Strategy has been developed and is being revised and implemented, as needed, to ensure learning environments are inclusive and respectful; free of racism and discrimination;
- Grades 7-12 teachers and administrators participated in professional development using the resource Stolen Lives: The Indigenous Peoples of Canada and the Indian Residential Schools:
- First Nations, Métis and Inuit Studies AQ courses and other learning opportunities related to Indigenous histories, cultures and perspectives have been offered for reimbursement to educators;
- Indigenous Reads Book Club being offered to all secondary teachers and administrators;
- we continue to purchase and provide appropriate resources related to Aboriginal education shared, system wide, as they become available (Board-wide memberships and digital resources);
- a learning continuum is being developed and implemented to ensure that students at each grade level have learning opportunities connected to Indigenous histories, cultures and perspectives;
- NBE3U Understanding Contemporary First Nations, Métis and Inuit Voices has replaced ENG3U in all secondary schools. This course provides important learning opportunities for all students about Indigenous histories, cultures and perspectives through literature; and
- School Improvement Plans include First Nations, Metis and Inuit education goals, specific to the needs of each school. Funds and resources have been shared with schools to support the implementation of these goals.

4. <u>Supports for Aboriginal Education</u>

- 4.1 Program staff (First Nations, Métis and Inuit education coordinator and resource teacher) continue to work collaboratively within system initiatives to provide learning opportunities that support staff and student learning.
- 4.2 Partnerships are important to support First Nations, Métis and Inuit student success and retention and demonstrate the principles of relationality and respect. We continue to work closely with a number of community partners to support our schools and students through the work of the First Nations, Métis and Inuit community liaison officer.
- 4.3 Aboriginal achievement tutors continue to work in all secondary schools and four elementary schools to support First Nations, Métis, and Inuit students' achievement and well-being.
- 4.4 Graduation coaches are working with Grade 9 students who have self-identified as Indigenous at all secondary schools to ensure that students are engaged and successful in school. Graduation coaches also build relationships with the students and their parents/guardians in the Grade 8 family of schools to promote a positive transition for students from elementary to secondary school.
- 4.5 Kendomang Zhagodenamnon Lodge, an alternative secondary program, is being offered for self-identified First Nations, Métis and Inuit students in partnership with the Thunder Bay Indigenous Friendship Centre based out of Hammarskjold High School. This unique program supports the transition to secondary school through culturally focused, land-based learning opportunities.
- 4.6 First Nations, Métis and Inuit Studies and Native Language courses continue to be offered system wide at the secondary level, in Armstrong and in select north and south zone elementary schools. In this 2020-2021 school year, the FNMI Studies English Course, Understanding Contemporary First Nations, Métis and Inuit Voices replaced all course offerings for Grade 11 University English.
- 4.7 Native Language programming has expanded to include an additional elementary school in this school year. This program has been supported through community partnership to include a fluent language speaker who supports the qualified teacher with program delivery.
- 4.8 Mino Bimaadiziwin, an Aboriginal Youth Leadership Program, is a collaborative effort between the Thunder Bay Indian Friendship Centre, Lakehead University Office of Aboriginal Initiatives, the Ministry of Education, and City of Thunder Bay Police.
- 4.9 Reach ahead credits are being offered to all self-identified First Nations, Metis and Inuit Grade 8 students entering secondary school in August.

5. Responses to COVID-19 Realities

5.1. We have responded collaboratively with many First Nations community partners to support remote learners who have stayed in their First Nations communities as a result of COVID-19.

- 5.2. In response to low engagement by many First Nations students and families in Lakehead Virtual Elementary School, an Indigenous youth engagement worker was hired to support and engage these students/families.
- 5.3. Remote First Nations secondary students struggled to engage in learning early on. As a result, additional alternative education periods were given to hire teachers who would specifically support students learning in remote First Nations communities.

We will continue to offer summer programming to support the re-engagement of students/families as we prepare for return to learning in September.

6. Next Steps

- Re-engagement and rebuilding of relationships with families and students whose learning has been interrupted by COVID-19. Supporting families and students as we transition back to face-to-face learning.
- 6.2 There is a continued need to provide significant levels of support during the various transitions experienced by Indigenous students.
- 6.3 A key strategy to build on leadership skills and strengths of students is to increase peer leadership opportunities for self-identified First Nations, Metis and Inuit students.
- 6.4 Increase access and availability of land based learning opportunities for all students.
- 6.5 Lakehead District School Board will continue to work towards identifying factors contributing to the gap in achievement between self-identified students and non-Indigenous students and implement effective strategies to meet the needs of diverse learners.
- Data collection and analysis will continue to support next steps in programming for First Nations, Métis and Inuit students.

7. <u>Conclusion</u>

Lakehead District School Board continues to make informed decisions about improving achievement and closing the gap in achievement between First Nation, Métis and Inuit students and non-Indigenous students based on student achievement and engagement data. By making informed decisions and providing programming that meets the needs of these students, Lakehead District School Board is ensuring high levels of public confidence and a spirit of hope for the future of Indigenous students.
