This email has provided members with a zoom link to the Children's Mental Health Northern Network for children zero to six years-old presentation.

9.1 <u>Lakehead District School Board COVID-19 Update</u>

Michelle Probizanski, Superintendent of Education, advised the committee that there was one COVID-19 case in one of the secondary schools. The Ministry of Education has asked that all Lakehead District School Board employees, and all organizations and/or partners, associated with the school board must provide attestation. Any person that is currently unvaccinated will now be required to provide a negative covid test, twice weekly. Asymptomatic pilot projects will be rolled out at Superior Collegiate and Vocational Institute and Westgate Collegiate and Vocational Institute, this will provide students at high risk and/or exposure, a take home COVID-19 testing kit. Also, a variety of Lakehead District Public Schools are currently providing vaccination clinics. All member's questions were addressed.
