- 9.3 Michelle Probizanski, Superintendent of Education, provide the below update;
  - mandatory vaccine for all students playing sports with SSSAA;
  - secondary semesters are back with four periods;
  - Covid-19 cases have increased. Elementary cohort are to be dismissed for 10-days, all students are encouraged to be tested immediately and then at day seven. Secondary, vaccinated students are able to stay at school;
  - Ministry of Education, issued Level One American Sign Language curriculum be included in secondary schools. This course will be offered at Westgate CVI and Hammarskjold High School;
  - Lakehead District School Board received transfer payments from the Ministry of Ontario, for Special Education Covid-19 Support. This will provide temporary support of Student Support Professionals and a Special Education Facilitator. Mental Health Covid-19 Support funds were also received, these funds will support a Social Worker, a Child Youth Worker, Attendance Counselor and co-curricular programs;
  - pediatric clinics will continue to be supported by LDSB; and
  - financial support was received for the Autism After Schools Development Program and is now supported in the Grants for Student Needs.

# 10. Information/Inquires & Association Reports

- 10.1 Trustee Sitch, expressed his commitment of support to SEAC, as this is his first SEAC meeting attended.
- 10.2 Liz Tod, Learning Disabilities Association of Ontario, informed SEAC that information on the Ontario Autism Program (OAP) was received and is launching in September 2022. George Jeffrey Children's Centre (GJCC) will be partnering with Lakehead Public Schools (LPS) with this initiative. The program provides support for Junior Kindergarten to Grade One transitioning from their home to school. A suggestion to have a representative from George Jeffrey Children's Centre attend the next LPS Junior Kindergarten information registration evening. Michelle Blackburn, GJCC, will provide an OAP presentation at the next SEAC meeting in January 2022 and will send any additional correspondence to Christine Jones, Executive Secretary, for SEAC.
- 10.3 Trustee Arnone shared a message from Trustee Susan Doughty-Smith, expressing her gratitude to all members of SEAC.

10.4 Michelle Probizanski, Superintendent of Education, confirmed the kindergarten registration evening is being held at Ecole Elsie MacGill, currently in person this year and grade 8 open houses, currently in person, at all secondary schools.
