## Navigating Grade 9 Pathways

Grades 9 and 10 are the time when students are learning about themselves as learners and the possible pathways they may take. For this reason, Ontario schools no longer require students to pick their academic pathway in Grade 9. This means that students no longer choose between Academic and Applied in Grade 9, providing all students with the opportunity to explore a variety of subjects and discover their interests.

For the 2024-25 school year, all grade 9 classes, except French, will be Open or De-streamed. These classes focus on foundational skills and support students in determining their pathways. As part of the requirements to graduate, Ontario students are required to take one credit in technology and one in physical education. At Lakehead Public Schools, students may choose, starting in the 2024-25 school year, to take these compulsory credits in either Grade 9 or 10. Students have the option to enroll in both courses during Grade 9 or defer one to Grade 10, providing the opportunity to pursue other interests, such as Art, Music, Drama, or Business. These changes are reflected in this form.

*\* This change does not apply to students who are registered in specialized programs such as PWP, multi-needs/special needs, or students planning on taking locally developed compulsory courses. If these courses are the best fit for students in your home, please communicate with the school to ensure we are best meeting the needs of your child.*
