The Lakehead District School Board (LDSB) is offering for sale, by sealed bid, the following vehicles: one (1) 2010 Chev Silverado with plow, one (1) 2002 GMC Diesel, one (1) 2011 Chev Silverado, two (2) Alpine II Skidoos. These vehicles were used by the Maintenance Department & Kingfisher Education Centre and are listed in the Bid Form – Appendix A. Below are the conditions of Sale that will apply.

SPECIFIC CONDITIONS

1. Vehicles will be sold without any warranty or safety on an “As Is, Where Is” basis. The LDSB will not be responsible for any repairs to the vehicle sold.
2. All offers are subject to a “reserve bid” (minimum acceptable bid) as indicated on the Bid Form.
3. Payment must be made in full within five (5) working days after notification of acceptance of bid, to reception at LDSB, 2135 Sills Street.
4. Payment must be made by cash, credit card, certified cheque, money order or bank draft made payable to the “Lakehead District School Board.”
5. All vehicles purchased must be removed at the bidder’s expense within seven (7) days after notification of acceptance of bid. Arrangements for time of removal are to be made with Don Porter (cell# 807-626-6771). The LDSB reserves the right to dispose of the vehicle sold that is not removed in the allotted time above.
6. Bids are to be received NO Later than Wednesday, May 1, 2024 - 2:00:00 p.m. local time.

10. LDSB reserves the right to withdraw any vehicle during the course of this sale and disqualify bids submitted that are not in accordance with this document.

11. Where identical bids are received, submissions will be evaluated in order of receipt by the purchasing department.
12. Bids may be submitted for multiple vehicles. Bidders must list the number of vehicles they wish to purchase and order of preference on the attached Bid Form – Appendix A.

In order to simplify and expedite the award, if you are purchasing more than one vehicle and bidding on numerous vehicles, as high bidder you will be offered the quantity of vehicles in the order of your stated preference only.

E.g. - intend to purchase two vehicles but are bidding on four vehicles. You are high bid on all four. Your order of preference on the bid was item# 2, 4, 1, or 5. You will be offered vehicles 2 & 4 only.
